### **Programmes in detail:**

#### **Children Care and Protection:**

Under this activity we are having threetypes of activities.

1. Home for the girls
2. Formal education
3. Child Safety Net

**1.Home for the Girls:** We established a girls home for the orphans, semi orphans and poorest of the poor in the rural areas. This activity is being supporting by CTW, Germany.since 2002. We are providing residential care services for 57 Girl children through the existing Stefan Children's Home. Some children are entered in to professional courses also. Four children has completed their engineering course.1 girl is in 4th year engineering



course. Children studying from L.K.G to 7<sup>th</sup> class are studying in our SNEHA (EM) SCHOOL. Other children from 7<sup>th</sup> to 10<sup>th</sup> are going to other Government schools. They are now going to the school by R.T.C. Buses. So we are looking for the school bus for transportation of the children which reduces the waiting time and children are able to concentration on their education more instead of waiting for the buses on the roads. All these girls came from remote villages. Some of them are semi orphans and some are from very poor back ground.

**2.Formal Education:** This formal school is established in the year 2000. SNEHA is providing the education to 154 children through our established formal school named **sneha (E.M) school**. This is a self sustained institution. No external support to run the school. School is being maintained with the nominal fee collected from the children. We established the school in order to provide quality education to the poor communities who are not able to compete with other sections in the society. We are providing free education to 3 children as for the provision of RTE Act.



**3.Child Safety Net:** This is a net work programme. There are nine NGOs who are the partners in the programme. This was designed to implement in coordination with the village communities. Their participation is necessary as the children belongs to their own village. The nine NGOs cover majority of the villages in the district. Under this we are covering 15 villages in three mandals kalidindi, kaikalur and Mudinepalli. We established child parliaments in the villages covering eligible children in the village. established Village level vigilance committees which is having 7 members in the committee. They were trained to prevent and stop the child abuse, child marriages and child trafficking etc. We are conducting tuition centers in all the villages to improve the education standards of the village children. There are 480 children who are benefitting through these tuition centers.



## NABARD interventions

### 1.Tribal Development :



Tribal Development activity has entered in to 7<sup>th</sup> year. The survival rate of plants is good. More than 87% Plants are in good condition. Tribal families who has covered through this programme are able to increase their livelihoods through implementation of internal crops. All the internal crops are commercial crops. They are now able to sell their products in nearby markets. We also established the local collection centers this year.

This Maa Thota Development programmes for the tribes in Krishna district has been implementing by SNEHA in Mylavaram and G.Konduru mandals with the support of NABARD, RO. We are covering 650 tribal families through this programme.

SNEHA has completed plantation in 420 acres. Now all the plants are producing the mango, guava fruits. The existing lands was provided with sufficient water for protecting the plants throughout the year. All the lands are covered with fencing. With out this the plant survival is not possible. This is one of the major requirement for success of SNEHAs Maa Thota activity. The 150 land less tribes who received the support for buffalos, goats and sheep and poultry are able to get very good livelihood support. They got good income out of selling the old animals also.



The established Maa thota Development committee was well trained to manage the Wadi programme. Also the Village Development Committees in 6 villages also trained and they involve all the farmers in the village level cooperatives.

### **Prevention of HIV/AIDS**



Prevention of HIV/AIDS among the migrant population is an ongoing activity since 2008. SNEHA is implementing this programmes in 9 mandals of Krishna District with its field office at Ibrahimpatnam. APSACS is continuing its support to implement the activities. About 15000 migrants are enrolled and new areas are identifying as the industrial area and construction workers are migrating more and more to involve in A.P state capital works. .

All the planned programmes are successfully being implementing by SNEHA. Condom promotion is successfully implementing in the project area. New hot spot areas were identified to put the stocks. The identified HRGs are referred for necessary follow up. BCC activity and other planned activities are successfully implementing. Number of ICTC checkups was regular and increased. The introduced CBS testing are being taken up in all the industrial and construction areas to identify the HIV effected if any. It is observed that the people are prepared to use social marketing condoms.

### **Toilets Construction**

Individual toilet construction programme under swatch Bharath supported by TATATRUST through MARI and AGS has been implemented by SNEHA in 10 mandals of Krishna District. We constructed 1730 individual toilets in the District.

The identified beneficiaries were properly trained in toilet usage. TATA TRUST provided very good moral, technical and financial support for the programme through MARI. They involved local Governments in every aspect. The department personnel extended their cooperation to meke it as successful.



### **Other programmes:**

#### **AIDS awareness:**

HIV/AIDS awareness programmes was organized in 32 schools and 12 colleges in Krishna District. This is a continuous programme. Like every year, we have Participated in World AIDs day programme organized by the District administration at Vijayawada. We also organized HIV/AIDS awareness programme in Mylavaram, Gudivada, and kaikalur mandals covering 28 villages. SNEHA Provided cloths and books to 36 infected children.





Organized awareness programmes for the SHG members, farmers in 4 mandals of Krishna Dt. More than 1430 SHG members participated in the awareness programme.

We have organized 2 medical camps for children in Mylavaram and Gudivada mandals. More than 290 children utilized the service. Distributed simple medicines to the needy Children. Referred the required children to the specialized hospitals.

We have provided books, pouches, pads and slates to 200 children in 10 villages in 2 mandals.
